

M1 x Oppo Pad Neo x Eazie TV Promotion

You are deemed to have (a) agreed to these Terms and Conditions; and (b) consented to the collection, use and disclosure of your personal information to M1 Limited (“M1”) for the purposes of administering the M1 Oppo Pad Neo with FREE 6 months Eazie TV subscription (“Promotion”) and to the M1 Data Protection Policy available at www.m1.com.sg/data-protection, by your participation in the Promotion.

7. Subject to these Terms and Conditions, each eligible customer who meets the conditions stated in Paragraph 6 above will receive a redemption code for the free 6 months Eazie TV subscription starting from the date of purchase.
8. Customer has the option to cancel their Eazie TV subscription any time. In the event that the customer cancel their Eazie TV subscription during the free 6-month Eazie TV subscription period, any remaining unused months of the free 6-month Eazie TV subscription period will be forfeited and will not be refunded.
